5. Matters arising from last meeting

Hedge – Cllr Cantwell has cut the hedge on the corner of Queensmead, this is not really a job for the Parish Council but was done due to the number of complaints being received. Cllr Hammond thanked Cllr Cantwell.

Dropped kerbs Queensmead – Planning enforcement looking at. Dropped Kerbs Headlands to be reported again. Footpaths also in need of slurry seal down there too

Parking North Street – Planning enforcement looking into, with hindsight the council should of insisted on double yellows being put down.

Wheelchair roundabout in place and being well used. A join in the artificial grass need to be re done as it coming up. Streetscene to visit.

Cllr Robinson asked the clerk to send a copy of the playground report to Streetscene this has already been done.

Grass cutting – clerk has spoken to grass cutting contractor who is happy to follow the requests made although some items have left him confused as to why he being accused of them. To move forward it was agreed to make a one off payment of £200 proposed by Cllr S Turner and seconded by Cllr Robinson to help cover additional expenses being incurred due to the rise in fuel etc.

It was also agreed that the current contract for grass cutting be finished on 31st October and new tenders be invited in December to allow additional time in which to look at Precept as

the price is expected to go up by a lot. Cllr S Turner and Cllr Cantwell to look at jobs list they want including in the tender.

Cllr Cantwell reported the old graves need strimming and a buddleia in the church wall needs removing.

Cllr Robinson asked that the long grass under the chop Stix climbing frame be cut back

Cllr M Turner to price parts for repairing, glass sizes to be given to clerk to allow price to be gained for windows to be replaced by pictures done on diabond. Concern raised over damage which could be done by a number of children behaving badly in the village currently. PCSO Bainton suggested speaking to other village groups about getting something started. And costs could be applied for from the police crime commissioners grant funding.

The council wished to congratulate the former Aldbrough resident Carol Thomas awarded the BEM in June 2022 for services to women's football and second captain to England's team to be minuted.

Cllr Robinson has been quoted £250 for playground check currently pay £81 to remain with current one.

Further hedges reported as being overgrown Councillors to speak to owners to have them taken back. Cllr Hamonad suggested a hedge trimmer be purchased to allow Cllr Cantwell go chop areas of greatest concern, whilst it is not the job of the parish council it was agreed to

get a battery powered trimmer for urgent cases, not be used instead of requesting the correct procedures.

Bin on Headlands Door has come off, to request a new one.

To request that the areas aound bins/signs/trees be strimmed or sprayed off as getting out of hand.

Cllr Robinson requested that the grass area outside his house be left for him to manage, clerk to request.
